PUBLIC ACCESS: Craig Knight – Voiced concerns with towns people potentially losing the use of the boat launch on Rooks Road, which is the only access to the water on Davis Pond. Russell said he believes that the land is currently under contract and was told that the current owner had encouraged the new owner to contact the state, in hopes they would purchase it and make it a public landing. Knight felt it would be best if the town could purchase and take control of it.
