MINUTES

CALL TO ORDER & FLAG SALUTE: R. Wood, Jr. opened the meeting at 6:00 pm

REPORTS: Fire: Chief Ellis submitted his report for May. Ellis reviewed the current state of the department staff, the live in program and an update on Grants. Eddington Fire has received just over a half million dollars in grant money since 2009. Kudos to Capt. Craig Russell for a job well done.

Police: Deputy Watson is on vacation this week. His report was included in Selectmen packets.

<u>CODE ENFORCEMENT REPORT</u>: Dean Bennett submitted his report and included material for board members to review on noise regulations.

<u>NEW BUSINESS</u>: Approval of Road Name for 911 Purposes – A motion was made, seconded and passed to approve Hilda Way, located off Jarvis Gore Dr. D. McCluskey / P. Chapman Vote 4-0.

Fire Dept. Cost Recovery & Fee Schedule, updated fees for 2020 — Capt. Craig Russell spoke to the Board regarding the process and its success during the first year. He determined that fees for Eddington were extremely low compared to the rest of the state. He prepared an updated fee schedule that was more in line with other municipalities. MRC Letter – Coastal Facility closed temporarily. Trash will be going to the landfill while contractual issues are solved. No action needed, more information to come.

Bangor Humane Society – Renewal Addendum (mandated) requires signatures. A motion was made, seconded and passed to sign the Addendum.
