PUBLIC ACCESS: No questions asked.


PUBLIC SAFETY REPORTS:




Ellis spoke about a recent grant, from the Stephen & Tabitha Kind Foundation. The grant money funded a thermal imaging camera for the department.



Nomination Papers – Reminder only. Papers due by April 25th, 2014.


OTHER BUSINESS: 2014 -2015 Budget – Workshops to be held on the following Tuesdays 04/29/2014 and 05/06/2014.




