**CALL TO ORDER & FLAG SALUTE:**



The meeting was called to order by Chairman, Mark Carreira, at 6:00 p.m.

**ROLL CALL:** All members present

**UNFINISHED BUSINESS:** Planning Board Member Revisit : David Peppard noted that several people had asked him to reconsider his decision to resign. Peppard said he would reconsider his resignation if the Selectmen were more supportive of the Planning Board's ability to identify what issues should go to a vote, saying that this was more democratic. In his comments, Ray Wood pointed out that the two boards have different responsibilities, yet no one wants to see David get done and that Selectmen do appreciate the work the Planning Board does. **A motion was made, seconded and passed to rescind the resignation of D. Peppard. P Chapman / Deanna Doughty Vote 4-0.**

Chemo Pond Road Paving - Final Plan discussion. As a result of a discussion regarding the current bidding procedures and why the policy was implemented, the selectmen agreed that sometimes there will be things that will need to be overridden. **A motion was made, seconded and passed to amend the current policy to add \*In the case of an emergency situation the Board of Selectmen reserve the right to seek a bid from a single source\*.** **D. McCluskey / P. Chapman Vote 4-0.**

After a few details were discussed for the construction portion, the board agreed to accept the proposal by L.P. Williams. A motion was made, seconded and passed to accept the bid as presented by L.P. Williams for the 4600 feet of road repair needed before it is paved. Selectmen requested that Shawna provide them with progress reports. **D. McCluskey / R. Wood, Jr. Vote 4-0.**






