EW BUSINESS: Tax Acquired Property Bid – A motion was made, seconded and passed to accept the bid by Natia Look in the amount of \$26,000.00, for the property at 56 Clewleyville Road and sign the Quit Claim Deed once prepared.

Davis Road Bridge Replacement Project Bid – A motion was made, seconded and passed to award the bid to the lowest bidder, Hughes Brothers.

Tax Assessor Ben Birch – Mr. Birch came to speak about the revaluation process, which was initially going to be hired out, but he has changed the direction to save money and manage it in-house. The tax maps are being updated (the last update was in 2009). He has hired a property lister who will work in the office taking the existing property cards and creating new ones with updated sketches and adding zoning codes. The data is being verified in person by another person who will work out in the field. Birch told the board that the town is losing 8-9% in value based on the last 2 years of sales. If a house is sold, it reset the value? No, it does not. Birch offered to do a PowerPoint presentation after Town Meeting.

<u>UNFINISHED BUSINESS:</u> Final Review of 2021 / 2022 Budget — The only addition to the budget from the previous meeting was a \$1000.00 donation request from the Manager in the Town of Bradley, who hopes to form a Dam Coalition between the towns Bradley, Eddington, and Clifton. The goal is to work with Leonards Mills in a joint effort to make sure the planking is in at the right time to keep the water level uniform. This donation would help with the legal and engineering fees.

OTHER BUSINESS: Next Meeting date – May 4th – A Public Hearing on the Warrant Articles, to include Planning Board Ordinance Changes.
